

**NOTICE INTIMATING CONSOLIDATION OF CORPORATE INSOLVENCY
RESOLUTION PROCESS OF TEN CORPORATE DEBTORS WITH DARSHAN
DEVELOPERS PRIVATE LIMITED**

The Hon'ble National Company Law Tribunal, Mumbai Bench ("NCLT") had *vide* separate orders admitted petitions and directed initiation of the corporate insolvency resolution process ("CIRP") of the eleven (11) Corporate Debtors (as mentioned in Annexure I) in terms of the provisions of the Insolvency and Bankruptcy Code, 2016 read with the rules and regulations framed there under, as amended from time to time ("Code"). The public announcements inviting claims from the public at large for each of the Corporate Debtors were made on the respective dates specified in Annexure I hereto. Subsequently, the NCLT *vide* an Order dated April 10, 2023 (published on April 18, 2023) ordered the consolidation of the CIRP of ten (10) Corporate Debtors (mentioned at Sr. Nos. 2 to 11 at Annexure I) with the CIRP of Darshan Developers Private Limited (mentioned at Sr. No.1 at Annexure I) and confirmed appointment of the undersigned as the Resolution Professional for the consolidated CIRP.
